### AMOUNT OF SCHOLARSHIP

The North Central Massachusetts Association of REALTORS® Memorial Scholarship awards are each \$1,500.

### QUALIFICATION OF APPLICANTS

Applicants must have successfully completed their junior year in high school and must have sent application(s) to an accredited college or university.

Individuals related to NCMAR members or employees shall not be eligible to apply for or receive this scholarship. Family shall include children, brothers, sisters, nieces and nephews, cousins and grandchildren. If you are unable to apply for this scholarship due to these restrictions, you may apply for the Willard Ide Shattuck Memorial Scholarship instead.

### APPLICATION PROCESS

All applicants must provide the following items to be considered for this award.

- APPLICATION: Applicants must complete the application form on the next page.
- TRANSCRIPT: Applicants must enclose their high school transcript.
- ACTIVITIES: Applicants must provide a list of extra-curricular activities including sports, student groups, community service and employment for the last four years as well as any academic honors received.
- ESSAY: Type on one page (double spaced) the reasons why you should be considered for this scholarship. The topic is up to each applicant but we do suggest a topic that represents you and your goals for the future.

Applications that are incomplete will not be considered.

APPLICATION DEADLINE – **Friday, April 26, 2024** All applications must be received by this deadline to be considered. Decisions by the Scholarship Committee are final.
