



**2025 Willard Ide Shattuck Jr Memorial Scholarship  
and

**AMOUNT OF SCHOLARSHIP:**

The \$1,500 Willard Ide Shattuck scholarship will be awarded by the North Central Massachusetts Association of REALTORS® Scholarship Trustees, with the approval of the Board of Directors of the North Central Massachusetts Association of REALTORS. The \$1,000 Law Office of David Rocheford Scholarship will be chosen by David Rocheford.

**QUALIFICATION OF APPLICANTS:**

- A. All applicants shall be a member of the family of REALTORS or Business Partners (in good standing) of the North Central Massachusetts Association of REALTORS®.
  - a. Family shall include children, grandchildren, siblings, nieces and nephews.
- B. In selection of the recipient, the Selection Committee shall be guided by the character, desire and scholastic ability of the applicant. In all events, the decision of the Scholarship Selection Committee shall be final.
  - a. Award recipients will be notified by email in May.
  - b. Actual award of scholarship shall be given to the recipient upon verification of student's second college semester matriculation.
- C. A student who has been awarded and has received from this fund is eligible to apply and receive additional scholarship awards.
- D. Members of the immediate family of NCMAR employees shall not be eligible to apply for or receive this scholarship.
  - a. Immediate family shall include children, brothers, sisters, nieces and nephews.
- E. Applicants must have successfully completed their junior year in high school and applied to attend an accredited college or university or be currently enrolled in college.

**APPLICATION PROCESS:**

1. *APPLICATION*: All applicants must fill out the form on the second page completely.
2. *ACTIVITIES*: All Applicants must provide a list of extra-curricular activities including sports, student groups,
3. community service and employment for the last four years as well as any academic honors received.
4. *ESSAY*: State in 300 words or less why you should be considered for this scholarship. In your essay we encourage you
5. to provide detailed justification for your candidacy for this scholarship.
6. *TRANSCRIPT*: Please enclose the most recent high school and / or college transcript.
